Proposed Changes to the Sacramento Youth Soccer League Constitution & By-laws
Rules and Regulations

Constitution and By-laws (2/3 majority required to pass)

Shall 1:06:01 be changed as follows?

1:06:01 Membership in this League shall be by affiliated Club. All clubs, **except Sacramento United**, shall consist of ~~four (4)~~ **five (5)** or more recreational **(division 4)** teams.

Shall 2:01:01 F be changed as follows?

2:01:01 F Treasurer

The Treasurer shall ~~give~~ **keep** a receipt for all monies which shall be deposited in a recognized bank in the name of the League. All accounts shall be paid by check and shall bear two (2) signatures ; that of the Treasurer and that of the President, Secretary or Registrar. No two persons related by blood or marriage shall be allowed to co-sign the same check. The receipt book and vouchers shall be produced when required by the Board of Managers, properly balanced according to the bank statement which is up to date. The Treasurer shall prepare and file, **or oversee the filing**, of all State and Federal Income Tax Returns, the Annual State Attorney General Periodic Report and any other necessary forms required by government agencies for his/her term of office.

Shall 2:02:05 be changes as follows?

2:02:05 The Treasurer shall establish and chair the Budget/Finance Committee. This Committee shall be comprised of at least two members of affiliated clubs, who are not members of the Executive Board. This Committee shall have the responsibility to: 1) review all financial transactions for the preceding year and prepare a financial report for the Board of Managers, and, to prepare a proposed operating budget for the coming year. These reports shall be presented by the Treasurer at the ~~Annual General Meeting~~ **April Board of Managers meeting** and the operating budget shall be deemed approved by an affirmative vote of a simple majority of the votes cast.

Shall 2:03:02 D be changed as follows:

2:03:02 D Select uniform colors (or color), **to be used by all their teams**, which are not the same as those of any other affiliated club.

Shall 2:11 be deleted in its entirety and subsequent sections renumbered accordingly?

~~2:11 All officers of this League and officials of member teams and players shall be covered against personal liability claims by the California Youth Soccer Association for performing acts and duties directly related to the work of this League~~

Rules and Revisions (simple majority required to pass)

Shall 3:04:09 be changed as follows?

3:04:09 No coach, substitute, player or spectator is to use any ~~mechanical device or air horn~~ **artificial device for purposes of noisemaking**, except for rmedically prescribed vocal enhancers.

Shall 3:04:10 E be changed as follows?

3:04:10 E A Club may be fined ~~twenty (20.00)~~ **fifty (\$50.00)** for each ejection report not filed in a proper/**timely** manner.

Shall 3:05:01 be changed as follows?

3:05:01 A game shall consist of two (2) twenty (20) minute halves with a five (5) minute half-time. Substitutions will be allowed at a throw in, only by the team with possession of the ball, a goal kick by either team, at half time or for injury with the permission of the referee. ~~Teams may elect to four (4) ten (10) minute quarters. This must be agreed to by both coaches at the beginning of the game. If quarters are selected, substitutions may only be made at the one (1) minute quarter break, at kick off after a goal or for injury with the permission of the referee. The coach may not enter the field and the players who are to remain in the game may not leave the field during the quarter break~~

Shall 3:06:01 be changed as follows?

3:06:01 The following violations, **subject to review by the PAD Committee**, are grounds for forfeiture of the game in which they were committed:
