SYSL Board of Manager's Meeting

Tuesday, October 10, 2006

CALL TO ORDER:

Meeting called to order at 7:39 p.m.

ROLL CALL:

All clubs present except Southgate.

VISITORS:

Sophia, Sam, Gloria, Rebecca Davis, Angela Bribiescas, and Pam Mooney of Tahoe Park.

APPROVAL OF MINUTES:

Motion made by Bruce Mattos of Land Park and seconded by Tom Bistline of Greenhaven to approve the minutes.

Motion passed unanimously.

FIRST VICE REPORT:

Sarah Najarro provided the PAD report. Things are improving. The number of red cards has decreased for recreational teams.

Sarah advised all club managers to remind referees that all players must have a player pass in order to play. No exceptions. No pass; no play.

She has games cards to return to Southgate, East Sac, Woodland, and Our Lady of Guadalupe, Parkway, Clarksburg, Greenhaven, Tahoe Park, River Park, South Florin, and Land Park.

It was reported that metro teams received 15 red cards this week.

HEAD COACH REPORT:

Steve Martinez reported that the "F" clinic last week had 22 participants. That is the last clinic for the season.

Reminder to all club managers that each metro coach listed on the Golden Rod must be certified referees by next season.

HEAD REFEREE REPORT:

Don Spicklemeir reported that the referee classes are completed. The number of referees certified has increased tremendously. The concern is that more youth are enrolling. Age will be asked at the time of registration and youth under the age of 16-years-old will not be allowed unless they are going to actually be utilized as referees.

There is a possibility that a clinic could be arranged if there were at least 30 coaches interested. If there are interested coaches in your clubs let Don know and more will be discussed at a future meeting.

TREASURER'S REPORT:

Hope Anaya provided copies of the report.

METRO REPORT:

Sarah Najarro reported that all teams have been moved up or down in division accordingly and managers have been notified. Revised schedules are available.

REGISTRAR'S REPORT:

Jennifer Neuner was not present but Marlene Vega shared the report on her behalf. At the present time we have almost 7700 players. Recreational registration has closed. The rule for Division IV is that players must be registered by the Sunday prior to the 5th game.

Please remind coaches that player passes cannot be transferred to a different club. They must contact the club registrar so things are handled properly.

Remind all Metro coaches that they are not to alter or mark-up the teams Golden Rod. If this occurs the team will not be able to register for tournaments or events. Contact your registrar if there are changes to be made.

SECRETARY'S REPORT:

Next meeting will be hosted by Sac United. It will be held at the Belle Coolidge Library on South Land Park Drive. NOT AT THE COMMUNITY CENTER. Sac United will provide someone to take the minutes for the November meeting as Secretary, Celia Garcia will be absent.

PRESIDENT'S REPORT:

Many teams in the U-8 and U-10 had very high scores (ie: 12-0, 13-1, 10-0). Coaches have been notified that this is not within the spirit of the game. At these ages it is critical to teach the players the concept of good sportsmanship and the spirit of the game. Once a score reaches five points more on one side the leading coach should intervene. This would be the perfect opportunity to work with the players on the passing game.

Remember it's not all about winning.

Michelle provided another perspective on the reseeding process. It is critical for the gamecards to be filled out with comments. Comment on other teams and skill levels when you call your scores in. This is helpful to those who are responsible for reseeding.

COMMITTEE REPORT:

Michelle extended her thanks to Steve Wong from Greenhaven for working with the City in her absence. The City has started revoking permits for non-use without warning. We are going to have to work together to ensure that all fields and teams are covered.

Every practice time, game time, and field schedule must be provided accurately to the City to ensure that permits remain valid. Let the coaches know that the fields need to be used during the times they are requested or permits will be revoked.

Standings on the websites are accurate. New schedules will be available on Thursday October 12th at 7 p.m at Sidewalk Pizza in West Sacramento. She provided master field schedules. These are rec schedules only not CPL or Metro. There is also a set of standings in each packet.

OLD BUSINESS:

U8 play offsides. talk to the referee coordinators to inform the referees about these rules. The other situation is NO DUPLICATE numbers on the field. It is a CYSA rule.

NEW BUSINESS:

Dixon - how come there are no bathrooms at the games in Sacramento. Clubs need to inform other teams of this so that they can prepare. Porta-potties are expensive and many schools facilities are locked because of the liability and damage that could be caused.

OLG - Couldn't we add something to the game schedules that would identify fields without facilities? Not enough space.

GOOD OF GAME:

Nothing to report. Lost a Metro Coach

ADJOURNMENT:

A motion to adjourn was made by Bruce Mattos and seconded by Martin Brady.

All in favor. Motion passed unanimously.
