HEAD COACH REPORT:

Next year all applications will be due in the middle of May, and all packets must be complete. No incomplete applications will be accepted. Registration is final for Metro. Give a copy of the license to the registrar and to the Metro Coordinator. Each Manager is responsible for supplying that to both.

REGISTRAR'S REPORT:

Jennifer Neuner reported that Metro teams deadlines were set for July 7th and teams are still late turning in their paperwork. Teams can start registering as early as May 1st. Encourage your teams to register early. This will ensure that there is not a rush at the last minute. There are over 6200 players registered with the league. Now it is time to coordinate the player pass. July 28th is the deadline for rec teams to have their paperwork into the registrar.
