CALL TO ORDER:

Annual General Meeting called to order at 7:45 by Marlene Vega, SYSL president

ROLL CALL: All present except for Valley Hi. Tahoe Park hosted. Guests: Don Spickelmeir, former head Referee and Greenhaven Board member Mark Bearer.

APPROVAL OF MINUTES:

HEAD COACH REPORT:

The Land Park and Woodland "E" courses have been short participants...maybe only one "E" course next year? We have three "F" courses coming up: South Florin, beginning June 27, is full; Dixon, July 19, has about 5 openings; and Parkway, Sept. 13 is still wide open. Please check the SYSL website.

PRESIDENT'S REPORT:

Marlene has a District meeting tomorrow. The big topic deals with the issue of several leagues pulling their competitive teams (or allowing them to leave) out of District 6 / CYSA to join U.S. Club for fall play. Sac United has left SYSL although they are still affiliated for this year. Rumors abound as to how or why this happened. At the April meeting, league presidents met with the Playing League (CCPL) representatives. The Playing League decided to pull out because District 6 wanted them to commit to their CYSA league, although they could still dual register with U.S. Club. SYSL will look at putting together a competitive program for the 2010 season to offer all levels of play for our kids.

Sac United's position is that they hope Marlene goes back to District 6 to help return the rules back to where they were last year. They feel that they have spent 30 years building Sac United as a part of SYSL and would like to somehow stay affiliated.

This issue is now tabled until next month after Marlene goes to the District 6 meeting.

COMMITTEE REPORT:

Metro - we have 66 SYSL Metro teams. We will play two games on the weekend of Sept. 19-20 so we can have the tournament bye weekend on Sept 27-28 (don't forget to reserve your Metro field for Sunday 9/20!) The August mandatory meetings out in Orangevale haven't been finalized yet. Remember that either the head coach or assistant coach on record has to attend.

OLD BUSINESS:

Robert Marin wants to know next step about the Yuba City coach who wants to bring his Metro team to Woodland. Sara will go to the next Metro meeting to see what can be done about changing the rule.

South Florin is working on the design of the SYSL pin.

NEW BUSINESS:

East Sac has a u-8 player with development issues who is asking to stay u-8 instead of moving up to u-10. He is small in size and doctor's notes were presented. Land Park motioned and Tahoe Park seconded to allow him to stay down. Vote was 15-0-2 in favor with the stipulation that he can't participate in Soccerfest or other tournaments.

Steve Martinez wants to thank all the clubs that helped out with his clinics. South Florin is up 162 kids from last year. Thanks to Tahoe Park for hosting and providing pizza/salad/drinks/and desert.
