CALL TO ORDER:

Meeting called to order at 7:47 by Marlene Vega, SYSL president

ROLL CALL: All present except Clarksburg and OLG. Greenhaven hosted and introduced its Board.

APPROVAL OF MINUTES:

Motion to approve made by Woodland, seconded by Valley Hi. Motion passed unanimously.

FIRST VICE REPORT:

HEAD COACH REPORT:
