

# SYSL Board Meeting

# CALL TO ORDER:

Meeting called to order at 7:45

# **ROLL CALL:**

InterYouth hosted and introduced its Board. Absent: Clarksburg, WS, LP

# **APPROVAL OF MINUTES:**

Motion to approve made by Greenhaven, seconded by East Sac. Motion passed unanimously.

### **FIRST VICE REPORT:**

### **HEAD COACH REPORT:**

We have a Head Coach opening that really needs to be filled. We need Coaching clinics. Fruitridge is interested in hosting an "E" clinic.

# HEAD REFEREE REPORT:

East Sacramento and Dixon will have July clinics – dates and locations to be determined. Bruce is missing contact information on head referees for clubs. #### **TREASURER'S REPORT:**

After much discussion, Fruitridge motioned to approve the 2014-2015 budget with East Sac seconding. 8 votes for, 1 vote against, and 3 votes abstaining. Motion carried. Shane wanted it noted in the minutes that Greenhaven voted against the measure. Greenhaven then motioned to discontinue the \$11,000 allocated for medals in the above budget. River Park seconded. Motion carried 8 - 1 - 3.

# **REGISTRAR'S REPORT:**

All registration should be mostly done by now. Registrars should be inputting data and forming teams. Send in registration money to Jennifer. Remember the different fee structure between rec and comp players. Competitive teams should be formed and player passes handed out by end of June for tournament play. Besides registering for CCSL, players have to be entered into Affinity by Club Registrars. Jennifer will send out spreadsheet (borrowed from East Sac) to Club Registrars and Managers.
