### **HEAD COACH REPORT:**

### **HEAD REFEREE REPORT:**

Referee clinics have changed. We have to go through an online registration. Send Bruce dates and location. We need a minimum of 20 students for each class. There are four classroom sessions and one field. Cost is \$75 per person.

#### **TREASURER'S REPORT:**

Please reconcile your invoices with Jennifer by March 1, 2015, as I will be closing out the books at the end of March. I hand them over to the tax accountant for our annual tax filing in April.

We will have to discuss the unpaid registrations fees, specifically Tahoe Park. It is looking like we will not see any new payments coming in. Further, Cal North continues to invoice us for their half of the past season(s) registration fees or approximately \$7,100. As I reported over the last few months, Cal North doesn't keep a separate balance for last season. They just take the first payment of the new season and credit part of it to the last season outstanding balance. I can explain further next month if this didn't make sense. Please know I am working with them to create a separate invoice for the unpaid portion based on those unpaid club registration fees. Our tax accountant is looking into options that will avoid us from having to pay on something we cannot collect back from a club that has dissolved.

Due to fact that the BOM voted not to purchase medals/pins this season, our 4% reserve have a surplus of \$10,000 for a balance of more than \$20,000. I will have a final number next month when I submit the year-to-date budget and financial statement.

#### **REGISTRAR'S REPORT:**

Invoices were sent out to the Clubs. If you didn't receive one, then you didn't owe. There were six Clubs with invoices.

We've been quiet with Spring registration. But it continues.
