## **SYSL Board Meeting** Tuesday, April 11, 2017

### **CALL TO ORDER:**

Meeting called to order at 7:05

### **ROLL CALL:**

Greenhaven hosted at Robbie Waters Pocket-Greenhaven Library and introduced its Board.

Absent: Inter Youth, River Park

Guest: Megan from Positive Coaching Alliance

### **APPROVAL OF MINUTES:**

Motion to approve made by Land Park, seconded by Greenhaven. Motion passed unanimously.

### **FIRST VICE REPORT:**

No report

### **HEAD COACH REPORT:**

SYSL will host an E clinic June 25-26 at Cal Middle School and a free New Coach, entry level clinic July 15 also in Land Park. Parkway will also host an entry level clinic, date TBD

Sac North will host a D clinic in May at Inderkum High School May 12-14, second portion in July (need to have held an E license for 6 months)

Let Bruce know if you want to host a clinic

### **HEAD REFEREE REPORT:**

Mike explained the "new" off sides rule. Youth Soccer Ladder: Educate the Coaches, which will filter down to the players and then to the parents about the new offside rule

And referees need to be trained in the new rule

### **TREASURER'S REPORT:**

No report as Charles is out of town. Beth from Greenhaven asked for a total accounting from 2014-2016 as she was concerned about possible misappropriation of funds due to our former Treasurer. Beth also questioned whether the Executive Board should be having dinner out of the SYSL budget during their planning meeting. Clarksburg mentioned that it is a common procedure for this to occur at these meetings as she is on several Boards.

### **REGISTRAR'S REPORT:**

Almost everyone is caught up as far as registration fees.

Registration has been quiet, as far as teams for Spring and Cups. Our new Registration program is not up and going yet, so we are continuing to use Affinity. Each Club needs to contact the account manager, to let

them know which program you will be using. Each include online registration, but one offers more stuff like website, emailing and texting. Forwarded emails to registrars- check out webinars for more training, if someone needs extra help, we will look into it, most people will learn as you go....

Players will remain in the system for one year and coaches for three. Players will need to provide birth certificates if they didn't play last year.

#### **CCSL updates:**

Enrollment has been down for the past few years, perhaps due to coaches' requirement in SYSL: one coach needs E license, one coach needs an F license, and one must be current certified referee. We may want to see about changing coaching requirements.

### **OLD BUSINESS:**

TOP Soccer playdates, put on website, will be a program of SYSL. First year goal is four playdates with the first one scheduled tentatively for April 8<sup>th</sup>. Anyone with experience with fundraising, etc... should contact Mike Lefebvre. Volunteers are needed.

East Sac motioned and Greenhvaen seconded to allow all age groups to play up: "At the discretion of each Club, SYSL will allow players to play up two birth years (one age group) for the 2017-18 season." Vote was 7 yes, 2 no, 6 abstain. Motion carries.

### **NEW BUSINESS:**

We voted last April for a temporary reduction in U6/U8 fees.

Greenhaven made a motion to continue that temporary fee structure reduction in U6/U8 of \$15 per player continue for one year. Land Park seconded. Vote 8 - 0 - 4. Motion carries.

Greenhaven motioned to continue from May of last year when we voted to temporarily have SYSL pay for live scan fees for New head and asst. coaches for one year. Motion was made to continue for another year and Land Park seconded. Jennifer must be provided a list of these coaches by November 1. Vote was 10 - 2 - 1, motion carries.

Up for election next month at AGM: President, Head Coach, Head Referee, Registrar
